The owner, rider and any of their agents or representatives acknowledge that they participated voluntarily in the competition full aware that horse sport and the competition involve inherent dangerous risk, and by participating they expressly assume any and all risks of injury or loss, and they agree to hold the competition and its officials, director, employees and agents harmless for any injury or loss suffered during or in connection with the competition, whether or not such injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officials, directors, employees or agents. All horses exhibited will be entirely at the owner's risk. Submitting entry shall constitute acceptance by the owner and exhibitor of all provisions as set forth herein. The above-mentioned entities, as well as members of the Show Committee and their Associates cannot be held liable for loss or injury to the person or property of any visitor, guest or spectator.
