SHOW RULES

1. THE RULES GOVERNING THE INDIVIDUAL CLASSES AND THE FORMULA FOR JUDGING PERCENTAGES USED WILL BE FOUND IN THE CURRENT APPALOOSA HORSE CLUB or AMERICAN PAINT HORSE ASSOCIATION RULE BOOK.

- 2. No one shall approach the Judge with regards to a decision unless he/she first obtains permission from the Show Committee or Show Secretary who shall arrange an appointment with the judge at a proper time and place. No Exhibitor has the right to inspect the Judge's cards without his/her permission. THE JUDGES DECISION SHALL BE FINAL IN ALL CLASSES.
- 3 The Show Committee reserves the right to refuse any entry because of disrespect for the rules, intoxication, rough treatment of animals, or any other reason officials may deem reasonable cause.
- 4. Order of work shall be drawn by the Show Secretary prior to classes which work individually. ORDER OF GO SHALL BE DRAWN IN ALL INDIVIDUALLY JUDGED CLASSES.
- 5. All ApHC and APHA exhibitors must present the original or a legible copy of the front and back (when applicable) of the registration papers at the time of entry for each horse shown. Original or legible copy of membership cards showing current members must also be submitted for owner and handler.

NOTE: IF COPIES WERE SUBMITTED WITH YOUR PRE ENTRY AND FEES THEY WILL BE RETURNED AT THE SHOW.

PRE-ENTRIES ARE ENCOURAGED

- 1. Pre entries must be postmarked by: May 27, 2022. Post entries will be accepted only up to three (3) classes prior to the class to be entered.
- 2. All entries must be made on the official entry blanks furnished by the Show Committee and must be signed by the owner or authorized agent. Parents must sign for Youth exhibitors under the age of 18. Exhibitors are responsible for any errors on the entry blank. Presentation of signed entry blanks shall be deemed acceptance of these rules and in event of failure to sign the entry blank the first entry into the show ring as an exhibitor shall be deemed to be an acceptance of said rules.
- 3. No refunds shall be made on stall or entry fees without a signed veterinarian's certificate. All claims for any entry or stall refund must be presented to the Show Secretary prior to the start of the show.

Checks returned by the bank for any reason will be charged a \$30.00 penalty and will be added to the amount due. Accounts will be given ten days to be paid in full with cash or cash equivalent or they will be turned over to the sanctioning organization and the person will be suspended from further shows here.
